No expense for insurance in 2018. We now break out portion to both SD and HOA.

2019 Budget \$37,542.80

Increase in HOA fees of \$10.00 per billing period to cover slight increases in Landscaping costs and insurance.

### Managing Agent Report – John Safford, Edgewater Management

- Cleveland completed spring cleanup and repaired areas damaged by plowing and with all the rain, the grass has come in well. Cleveland cleaned sidewalk on Seward and billed Phase II - \$481.50.

- Dulmer will do the annual tree spraying this weekend. Dean requested a MSDS. Austrian tree along Seward that's turning red and two other trees that look dead we'll ask him to look at.

#### **New Business**

- Financial Reports: Since the board will not meet until September, Sean and John S. will meet every month between now and then to review statements and email board for comments and approval.
- Board would like to meet with Dave Evans & Claudia Braymer to get an update. Board agreed on Monday, June 10<sup>th</sup> at 6pm. Sean will reach out to Dave and Claudia to schedule a date. Tracy agreed to host.
- Architectural Review: Graff is doing a walkway. Has this been submitted and approved? Fil will follow up with John Essig on all the Architectural Review forms.
- Painting Schedules: Next time we paint is 2020. Sean & Dick will look into a painting reserve and review by-laws.
- Trees: Last fall we budgeted \$6300 for additional trees to be cut and new trees placed along Birch Run Drive however, board agreed to wait for these four trees (planted in 2018) to mature before cutting/planting more. Fil reports Canadian hemlocks along Seward were not planted all the way to the southern end and he would like this done. He would like the berm cleaned up on Seward behind his home where fallen branches and debris have accummulated.
- Trees along Birch Run Drive: board agreed to wait another year or two until they mature before we cut/replace more.
- Back in Fall 2017, 24 hosta's were planted at the entrance and only 2 hosta's came back. Tracy notified Brookside and they believe voles probably ate the root systems. Brookside suggested planting 5 winterberry shrubs instead of hosta's. They agreed to replant 5 shrubs for \$200 which includes labor. Motion to approve Dick, Fil seconds, all approve.
